Executive Summary

The attached draft Cabinet Paper seeks agreement to establish a new national emergency management agency (NEMA) in the form of a Departmental Agency to replace the Ministry of Civil Defence & Emergency Management (MCDEM).

The Cabinet Paper is being drafted by DPMC with SSC providing machinery of government advice. This briefing conveys SSC's advice on the departmental agency form and discusses two options for which government agency should host the departmental agency. It seeks your feedback with a view to including the options in the Cabinet Paper.

Joint Report: Advice on the National Emergency Management Agency (NEMA)

Purpose of Report

- 1 The core function of NEMA is to enable the Director Civil Defence and Emergency Management to meet their functions and duties and exercise their powers.
- 2 The proposed functions of the new National Emergency Management Agency (NEMA) are to:
 - Provide direction to the operations of the emergency management sector
 - Build the capability and capacity of the emergency management system to plan for, withstand, respond to, and recover from emergencies
 - Lead or support responses to, and recovery from, emergencies (irrespective of cause)
 - Provide assurance to Government and the public about the performance and capability of the emergency management system to respond effectively
- 3 The criteria for deciding on the form of NEMA is that it provides:
 - Greater role clarity at all levels within the system at the national level
 - Operationally-focused leadership, able to influence across the system
 - A shift in culture, objectives, business strategy, and operating model at the national level
 - Stronger system stewardship.

Analysis

- 4 The Ministry of Civil Defence and Emergency Management (MCDEM) has been performing well given its limited resources. Further investment would support its ability to deliver on the required shift identified by the Ministerial Review.
- 5 Regardless of additional investment, based on the proposed functions and set of criteria, SSC considers that the proposed new entity should take the form of a Departmental Agency (DA). Even with additional funding, delivering through a business unit of a government agency would be sub-optimal. The DA form provides an opportunity to consolidate operational and regulatory functions across all-hazards and risks, providing system coherence in all emergency management scenarios. The DA form will also provide the required mana or status of leadership and the greater autonomy required to deliver on its set of functions.
- 6 The DA form requires a host agency and this requires particular consideration in the context of how the National Security System (NSS) should operate going forward. Within the NSS there should be three clear roles. These are:
 - The role of lead agency to oversee risks and manage incidents before they are escalated to emergency status;
 - Managing an emergency, led by NEMA; and

- The oversight of the Officials Committee for Domestic and External Security (ODESC), supported by the NSS, in taking an All of Government perspective.
- 7 Arguments for retaining DPMC as the host agency of NEMA are that:
- Retaining NEMA's proximity to ODESC and the NSS provides more prominence and relationship capital to support NEMA's all-hazards mandate and its management of an emergency;
 - DPMC's position as a central agency reinforces NEMA's influence over government agencies;
 - It is comparatively easier and cheaper than relocation.
- 8 A clearer separation of roles would be less effective with MCDEM located within DPMC. Although the system could seek to achieve better separation without further structural change, there are three reasons for DPMC not to host the functions that would be performed by NEMA:
- As a policy agency at its core, DPMC is not best placed to support the enhanced operational functions of NEMA.
 - A disproportionately larger function, particularly in the form of business unit, could distract DPMC's leadership from its core role in advising the Prime Minister.
 - The DPMC CE holds an important role as chair of ODESC in taking an all-of-government perspective, including assessing the performance of NEMA. Maintaining this separation is particularly important during an emergency response.
- 9 Reasons for the Department of Internal Affairs (DIA) to act as host of the DA are:
- Strategic alignment: DIA can support NEMA through its policy and funding connections with local government and communities, which are a critical part of how the emergency management system works; it also has policy and monitoring responsibilities for Fire and Emergency NZ and is close to climate change adaptation and the resilience of the Three Waters (drinking water, storm water, waste water).
 - DIA can add value to NEMA: DIA can support the DA as it is a large operationally focussed agency that can provide the same expertise and a network of relationships that it already has established for other regulatory regimes.
- 10 There are some early indicative costings in the draft Cabinet Paper that will need to be completed.

Risks

- 11 Given that these functions moved from DIA less than five years ago, there are some presentational issues with DIA hosting NEMA. However, the Departmental Agency form is very different to that of a Business Unit. ODESC and the NSS has grown to be a much more mature network. Even if NEMA was not hosted by DPMC, the key relationship between the Prime Minister and ODESC would remain unchanged. The NEMA chief executive would be accountable to the Minister of

Civil Defence and the normal conventions between the Prime Minister and the Minister would then apply.
