REPORT AND RECOMMENDATION OF THE REVIEW PANEL

CANTERBURY EARTHQUAKE (HISTORIC PLACES ACT) ORDER NO.2 2011

1. On 15 June 2011 the Canterbury Earthquake Recovery Review Panel (the Review Panel) considered the draft Canterbury Earthquake (Historic Places Act) Order no. 2 2011 (version PCO 15177/1.3).
2. Review Panel member, Mr Anake Goodall had been involved in earlier consultation on this draft Order and he was not part of this review thus avoiding any perceived conflict of interest. Review Panel member, Mr Murray Sherwin was not available to participate in the review of this draft Order. This report and recommendation has been made by the other two members of the Review Panel
3. The Review Panel considered the letter from Peter Richardson of the Ministry for Culture and Heritage dated 8 June 2011 and noted that the objective of the proposal is to facilitate recovery by:
 - a. streamlining the New Zealand Historic Places Trust processes for determining applications to modify sites of interest to Māori in a way that balances the need to support the recovery and rebuilding of Canterbury against the need to protect sites of interest to Māori.
4. The Review Panel is of the view that the draft Order is necessary, expedient and meets the purposes of the Canterbury Earthquake Recovery Act 2011.

Recommendation

5. The Review Panel recommends to the Minister for Arts, Culture and Heritage that the Canterbury Earthquake (Historic Places Act) Order no. 2 2011 (version PCO 15177/1.3) be made without change.
