## Public Notice: Draft Lyttelton Port Recovery Plan

The Minister for Canterbury Earthquake Recovery, the Hon Gerry Brownlee, has received the draft Lyttelton Port Recovery Plan from Environment Canterbury (ECan). The preparation of a draft Lyttelton Port Recovery Plan was directed in June 2014 by the Minister under section 16 of the Canterbury Earthquake Recovery Act 2011.

The draft Lyttelton Port Recovery Plan was commenced by Lyttelton Port Company and then developed by ECan in consultation with Christchurch City Council, NZ Transport Agency, Te Rūnunga o Ngāi Tahu, Department of Conservation, Selwyn and Waimakariri District Councils and in consultation with the community. ECan also consulted with the Lyttelton Port Company.

The draft Lyttelton Port Recovery Plan has been publicly notified in The Press on Saturday 15 August 2015 and written comments on the draft Recovery Plan are being accepted up to 5pm on Monday 31 August 2015
