REPORT AND RECCOMMENDATION OF THE REVIEW PANEL

HURUNUI / KAIKŌURA EARTHQUAKES RECOVERY (RATING VALUATIONS ACT – KAIKŌURA DISTRICT COUNCIL) ORDER 2017

- 1. On 6 June 2017, the Hurunui / Kaikōura Earthquakes Recovery Review Panel (Review Panel) considered the above draft Order.
- 2. Having considered the reasons advanced by the relevant Minister and supporting documents from the Ministry for Land Information New Zealand, which we accept, we are satisfied that the Order in Council is necessary as it is not currently practicable for the Council to accurately assess the impact of the earthquake damage on property values.

3. Whilst it is not anticipated that any changes will be made to the Order, our decision is predicated that any such changes are not substantive. If the changes are substantive we will have to review this decision.

4. The Review Panel is of the view that the draft Order is necessary, expedient and meets

the purpose of the Hurunui / Kaikōura Earthquakes Recovery Act 2016 (the Act).

Reasons Recommendations and Brief Comments

5. Following the Hurunui / Kaikōura earthquake sequence, the Kaikōura district suffered

considerable damage to property. The district valuation roll is required to be updated every

three years through a general revaluation. Between this period, the Council has discretion

to reassess the rating valuations of any property where an "extraordinary event affecting

property values' such as the Hurunui/Kaikōura earthquake sequence has occurred.

6. A large portion of the Kaikōura district suffered damage and property owners may be

eligible for a rating reassessment. Due to incomplete data currently available regarding

the extent of damage and the associated cost of any repairs required to individual

properties, combined with limitations on physical access to properties, we agree that it

would not be practicable for the Council to accurately reassess the impact of earthquake

damage on property values within its district at this time. Reassessment of the district

valuation roll at this time would also be a resource intensive and costly process for the

Council and would likely divert financial resources from the earthquake recovery work

being undertaken.

7. The draft Order ensures that the Council's district valuation roll remains credible, and that

it has a workable property taxation system in place as it recovers from the recent

earthquake events. The Minister and the Ministry for Land Information New Zealand have

provided compelling reasons for this need in the reasons for recommending the Order.

8. We are satisfied that the Order has properly balanced the interests of the community, iwi

and environmental matters, and will aid the economic recovery of Kaikōura by giving the

Council a high degree of certainty over the rating values used to calculate rates whilst

the Order is in force.
