# Report on Overseas Travel: Rt Hon Jacinda Ardern

I recommend that Cabinet note this report on my travel to Beijing, China from 31 March to 2 April 2019 to reinforce the bilateral relationship through engagement with China's leaders, formally open the New Zealand Embassy, and engage with the New Zealand community in Beijing.

# Report

- I had planned to take up China's invitation to make a much longer visit, which would also have included attending the Bo'ao Forum, and visiting Shanghai to promote New Zealand business. I already had confirmation that a high-level trade and civil society delegation would accompany me; as well as several Ministers. In the wake of the Christchurch attacks, however, it was appropriate to reduce the scope and scale of the visit, to focus on the key element: the engagement with China's leaders in Beijing.
- 2 My visit focussed on underlining the strength of the relationship; demonstrating our broad shared interests; and identifying new areas in which we could cooperate in future.
- I received an official welcome and honour guard, and had substantive meetings with both Premier Li and President Xi, as well as a formal lunch hosted by Premier Li all of which underlined that the relationship is in good health.
- In my discussions with Premier Li we agreed to pursue new cooperation in climate change, and reached agreement to conclude the FTA upgrade negotiations and the Belt and Road work plan as soon as possible. Other key outcomes included a joint statement on climate change, establishing a financial dialogue, and an updated Double Taxation Agreement. We also witnessed the signing of arrangements launching a five-year agricultural cooperation programme, and new cooperation in science and innovation.

  Premier Li responded constructively.
- I had a similar discussion with President Xi; raising many of the same issues. He responded in a constructive way. His opening and closing statements were positive, and couched in terms of pursuing mutual respect, practical cooperation and common interests. <sup>6(a)</sup>
- Several Chinese Ministers were also present for the meetings and at lunch. With Commerce Minister Zhong Shan I discussed possible cooperation on WTO issues and the need to modernise, defend and improve the WTO itself. We both also welcomed the launch of the Year of Tourism, with Premier Li saying that he considered Māori culture to be a key driver for Chinese tourists' interest in New Zealand as a destination.

- I formally opened the new New Zealand chancery and residence in Beijing, in the presence of staff from all ten agencies represented (NZTE, MPI, Education, Police, Customs, Defence, MBIE Immigration, Tourism NZ, MBIE Science and Innovation, and MFAT). I also met a mix of Beijing-based business community members, and Executive Board members of the Shanghai-headquartered New Zealand Business Roundtable in China (NZBRiC). They were complimentary about the work of MPI and NZTE officials in China and noted that they were not experiencing any unusual market access issues. A key message from them was the particular challenge in China of being agile enough to stay ahead of emerging trends.
- 11 I also met with some mainly Beijing-based Kiwis in a large (more than 200 people) event at the embassy, and I did three high-profile Chinese media interviews with CCTV, Caixin and Weibo/Guangdong TV.
