

# Hagley Oval – Amendments to the Christchurch District Plan

## Section 71 Proposal – Greater Christchurch Regeneration Act 2016 | Overview

**The Proposal applies to Hagley Oval located at South Hagley Park, 57 Riccarton Avenue, Christchurch and was prepared by Regenerate Christchurch on behalf of the Canterbury Cricket Trust (the Trust).**

The proposed changes to the rules in the District Plan would replace the need for the Canterbury Cricket Trust to make any future application for resource consent in respect of those rules covered by the Proposal.

The rule changes relate to, amongst other things, flood lighting and the number of match days allowed.

The Trust's current 2013 resource consent allows for four retractable lighting poles. The proposed changes to the District Plan would permit six permanent floodlighting poles and structures. Regenerate Christchurch advises the proposed lighting changes would meet international broadcasting standards and enable Christchurch to bid for 'top-tier' international cricket matches in addition to the matches that can be bid for currently.

It is noted, there is a deadline of 20 December 2019 for a Christchurch bid to host 'top-tier' games – such as a final – of the 2021 Women's Cricket World Cup.

A table summarising what is currently permitted (through the existing resource consent) compared with the proposed amendments to the District Plan is in Appendix 2 of the Proposal.

Regenerate Christchurch considers using section 71 would be more efficient than making the changes using other planning processes such as those in the Resource Management Act 1991.

The Associate Minister for Greater Christchurch Regeneration (the Minister) publicly notified the Proposal on Tuesday 15 October 2019 and invited people to give their views in writing on the Proposal by **5pm, Wednesday, 20 November 2019**.

All written comments will be considered and will help the Minister decide whether to approve the Proposal.



### Christchurch City Council – separate Reserves Act process

In addition to the section 71 process, in order to install permanent floodlights the Canterbury Cricket Trust also requires a new lease with Christchurch City Council, which manages Hagley Park.

The Council is required by the Reserves Act to undertake public consultation of at least one calendar month when considering a new lease. The Council's consultation starts on 16 October and will remain open until Monday, 18 November 2019.
