Official Information Act request relating to OIA requests 1 March 2018 to 1 March 2021

Thank you for your Official Information Act 1982 (the Act) request received on 31 March 2021. You requested:

"Information in relation to all OIA requests you have received from 1 March 2021 to 1 March 2018."

I previously responded to a similar request made last year, and this response is publicly available on the Department of the Prime Minister and Cabinet (DPMC) website. It includes all Official Information Act (OIA) requests made to DPMC and the National Emergency Management Agency (NEMA) from 14 April 2016 to 7 July 2020. Accordingly, I am partially refusing your request pursuant to section 18(d) of the Act as some of the information requested is publicly available:

Please find attached a list of titles for OIA requests received by the DPMC and NEMA from 4 July 2020 to 1 March 2021. I note that the summary title does not reflect the existence of the requested information.

Some information in the list is withheld pursuant to section 9(2)(a) of the Act as the withholding of the information is necessary to protect the privacy of natural persons. In making my decision, I have taken the public interest considerations in section 9(1) of the Act into account.

You have the right to ask the Ombudsman to investigate and review my decision under section 28(3) of the Act.
