Official Information Act request for titles of briefings sent to Hon Andrew Little relating to the Royal Commission of Inquiry into the terrorist attack on Christchurch masjidain on 15 March 2019

Thank you for your request made under the Official Information Act 1982 (the Act), received as a transfer by the Department of the Prime Minister and Cabinet (DPMC) from the Office of Hon Andrew Little, Lead Coordination Minister for the Government's Response to the Royal Commission's Report into the Terrorist Attack on the Christchurch Mosques, on 30 April 2021. You requested:
