## Implementation Unit: Mid-Year Review of the Implementation Unit's 2022 Work Programme

## Proposal

- 1. This paper:
  - 1.1. Provides an update on the scope and timing of the Implementation Unit's (the Unit) existing approved commissions for the second half of 2022; and
  - **1.2.** Seeks agreement to a proposed list of additional priority programmes for inclusion in the Unit's workplan for 2022.

## **Relation to government priorities**

2. The Unit's operations are critical to enabling the successful delivery of Government priorities, particularly *accelerating economic recovery* and *laying foundations for the future*.

## **Executive summary**

- 3. The Unit continues to progress its work programme. Eight of the 11 commissions approved by Cabinet in March 2022 remain on its work programme for the second half of 2022. Two commissions have been completed and have reported back to the Cabinet Priorities Committee (CPC), with the third beginning a follow-on commission. For some commissions, the scope and/or timing of the Unit's intervention has been adjusted to ensure that the Unit can continue to add the greatest value to delivery. These adjustments have been made to, for example, accommodate changes to agency milestones, to better align with new agency timeframes, or to re-focus commissions on critical components of delivery.
- 4. As part of the Unit's ongoing work on the delivery of the \$1.9bn Budget 2019 Mental Health and Addiction Package, the Minister of Health and I have directed the Unit to source appropriate expertise and undertake a deep dive into each of the 16 Mental Health Infrastructure Programme (MHIP) projects. This is a priority piece of work to identify the status of delivery, robustness of estimated completion dates, and risks, barriers, and issues.
- 5. The Unit has retained capacity for the second half of 2022 to add additional programmes to its work programme [CPC-22-SUB-0003 refers]. A scoping exercise has been undertaken to identify appropriate programmes for inclusion, with a focus on programmes that are complex, represent significant government investment, and where successful delivery will generate broad benefits for New Zealanders (and in one instance for Pacific Island Countries). I am proposing that the Unit adds specific assignments for each of the following 6 programmes to its work programme for the latter half of 2022: *Immigration Rebalance; Census Readiness; Government Investment in Decarbonising Industry Fund; New Zealand's International Climate Finance Commitments; Delivery of Public Housing;* and *Provision of Housing Supply Initiatives*.

## IN CONFIDENCE

6. I will report back to the Cabinet Priorities Committee (CPC) on 6 December 2022 with the Unit's proposed work programme for the first half of 2023.

## Background

- 7. In March 2022, Cabinet agreed 11 commissions for Unit's work programme for 2022 [CAB-22-MIN-0057]. The Unit has delivered four reports since March 2022 on the following programmes: New Zealand Upgrade Programme, Emergency and Transitional Housing, Infrastructure Reference Group, and the Budget 2019 Mental Health and Addiction Package. It has concluded its working alongside role with the Ministry of Health for its support of its new performance monitoring arrangements; working arrangements with the new Health entities; and its Mental Health and Addiction programme.
- 8. I provided updates on the Unit's progress, including its reports and its findings, to CPC in December 2021, May, and June 2022. [CPC-21-SUB-0032; CPC-22-SUB-0012 and CPC-22-SUB-0016 refers].
- 9. In March 2022, Cabinet **noted** that the Unit retained capacity for the second half of 2022 to add additional priority programmes. Cabinet **noted** that I would bring an update to CPC in July, including any additional programmes to be included in the Unit's work programme for the second half of 2022 [CAB-22-MIN-0057]. This paper provides that update.

## The Unit's existing commissions for the second half of 2022

- 10. Eight of the 11 programmes approved by Cabinet in March 2022 remain on the Unit's work programme as at 1 July 2022. These are across the following programmes: *Carbon Neutral Government, Emergency and Transitional Housing, the Emissions Reduction Plan* (ERP), the Health Reforms, He Waka Eke Noa, the Immigration Rebalance, Te Aorerekura the national strategy for eliminating family violence and sexual violence, and the Three Waters Reform Programme.
- 11. The Unit's current commissions, the scope for each approved programme, and the timing of the Unit's work and intervention are summarised in Appendix A.
- 12. For some of the commissions, the scope and/or timing has changed from the initial commissioning brief agreed in March 2022. The rationale for the change in focus and/or timing of the support is included in Appendix A.
- 13. Amendments have been made to ensure that the Unit is able to add value through its involvement in programmes, and that the Unit's intervention continues to be timely and relevant as agency milestones shift or delivery progresses. This has meant, for example, that commissions have been amended to accommodate refinement of agency milestones (for example: *ERP*; *the Immigration Rebalance*), or to re-focus commissions on more defined elements of delivery (for example: *Three Waters*; *He Waka Eke Noa*). The Unit's planned stocktake of the delivery of the redesigned *Emergency and Transitional Housing* programme will not commence this year due to changes to the timeframe for agencies seeking decisions and consequently for implementation. The revised timing for the stocktake will be considered in the November 2022 review of the Unit's workplan.

## Mental Health Infrastructure Programme Commission

- 14. The Unit has continued its work on the delivery progress of the \$1.9bn 2019 Budget Mental Health and Addiction Package (the 'Package') through the first half of 2022.<sup>1</sup> As a follow-on commission from the Unit's second stocktake of delivery progress of the Package, the Minister for Health and I have directed the Unit to undertake additional work on the Mental Health Infrastructure Programme (MHIP).
- 15. We have directed the Unit to, with expertise and assistance from Te Waihanga the Infrastructure Commission and working with the Health New Zealand Infrastructure and Investment Group (IIG),<sup>2</sup> complete a deep dive into each of the 16 MHIP projects.
- 16. The deep dive into the MHIP will provide us with advice on:
  - **16.1.** For each MHIP project, the status of delivery, robustness of the estimated completion dates, and risks and issues.
  - 16.2. A delivery plan that will identify actions that will ensure projects gain momentum and get moving; and
  - **16.3.** An assessment of the capacity and the capability of IIG to implement the delivery plan.
- 17. This work is now underway, and the focus is firmly on the pace of delivery. The Unit and Te Waihanga, working with IIG, will identify practical actions that will 'get projects moving'. The Unit will ensure that Ministers are informed of actions as projects are reviewed and a final report will be produced by 14 October 2022.
- 18. I will bring to the August CPC meeting the Unit's Briefing on its Second Stocktake Report of progress on the \$1.9bn 2019 Budget Mental Health and Addiction Package, its findings, and an update of progress on the further commission on the MHIP.

## Proposed new commissions for the Unit for the second half of 2022

- 19. A scoping exercise has been undertaken to identify appropriate programmes of work for inclusion in the Unit's work programme, focussing on programmes that are complex, represent a significant government investment, and where successful delivery will generate broad benefits for New Zealanders.
- 20. I propose that the Unit adds to its work programme for the second half of 2022 a further 5 new programmes, with an additional commission for the Immigration Rebalance Programme (which is currently in the Unit's work programme as a working alongside commission).
- 21. The proposed scope, nature of the proposed intervention and timing is set out in Table 1.

22. If the commissions in table 1 are approved, the Unit will draft commissioning briefs in consultation with the relevant agencies. I propose that I will approve the individual commissions briefs, in consultation with relevant Ministers, for these new commissions.

## November review of the Unit's work programme

- 23. The Unit has two programmes on its work plan for the first part of 2023 these are a stocktake of the initial delivery of *Te Aorerekura*, and a stocktake of progress to review the readiness of agencies, local government, and the interim Local Establishment Agencies to assume the accountability and delivery functions of the new water service entities in the *Three Waters Reform* programme [CAB-22-MIN-0057].
- 24. In November a scoping exercise will be undertaken to identify programmes for inclusion in the Unit's work programme for the first six months of 2023. I will bring a draft work programme to CPC on 6 December 2022.

## The Unit's system-level work

## **N** CONFIDENCE

25. The Unit's role and function means that it is uniquely placed to be able to identify lessons learned regarding successful delivery and implementation across the public service. The Unit will complete drafting system-level guidance on implementing complex programmes in July and will continue to assess where additional pieces of system-level learning and guidance would be of value.

## Consultation

- 26. Te Tūāpapa Kura Kāinga Ministry of Housing and Urban Development; the Ministry of Social Development; the Ministry for Primary Industries; the Ministry for the Environment; Energy Efficiency and Conversation Authority; the Ministry of Business, Innovation and Employment, including Immigration New Zealand; the Ministry of Health; the Department of Internal Affairs and Te Puna Aonui were consulted on the existing commissions.
- 27. The Ministry of Foreign Affairs and Trade; Statistics New Zealand; the Ministry of Business, Innovation and Employment, including Immigration New Zealand; Energy Efficiency and Conversation Authority; Kāinga Ora and Te Tūāpapa Kura Kāinga – Ministry of Housing and Urban Development were consulted on the Unit's new commissions.
- 28. The Treasury was consulted on all commissions.

    - d. *New Zealand's International Climate Finance Commitments*: A stocktake of the Ministry of Foreign Affairs and Trade's (MFAT) delivery of New Zealand's 2019 to 2022 commitment (\$300m) and readiness to deliver on the 2022 to 2025 commitment (\$1.3b) in the context of International Development Cooperation (IDC) and the international frameworks for climate finance.

*Kāinga Ora delivery of public housing*: A stocktake of the progress of Kāinga Ora's public housing construction pipeline and delivery. This includes an assessment of housing location, type (such as new builds and leasing or buying existing properties), and progress in meeting milestones and targets set by Ministers.

- f. *Housing supply initiatives*: A stocktake of delivery of existing housing supply initiatives. This would be to ensure that non-regulatory supply initiatives are connected, lessons are carried across and effort is not being duplicated.
- (d) **Agree** to delegate the authority to the Deputy Prime Minister in consultation with relevant Ministers to approve commissioning briefs for each of the Unit's new commissions for the second half of 2022.
