Purpose

1. This aide memoire provides a brief update on the testing innovation work programme.

Regulatory workstream

Rapid review

- The rapid review of the COVID-19 Point-of-Care Testing (POCT) regulatory framework is expected to be undertaken in July-August 2022. Advice on any recommendations arising from the rapid review is expected late-August.
- 3. The governance arrangements for the rapid review will be finalised shortly. Draft Terms of Reference have been put together for review and approval by the governance group.
- 4. Engagement with a provider to undertake the review is underway.

Wider regulatory review

- A project plan for the broader regulatory review of COVID-19 testing has been developed, and a desktop scan of relevant documents on testing innovation is underway.
- 6. The Ministry of Health (MoH) Policy and Therapeutic Products Bill teams are working together to understand lessons learned from COVID-19 and to ensure work on both the review and the development of the bill is aligned and informing each other.
- 7. Testing Innovation workshops (as part of the innovation and futures workstream) in the next fortnight will also inform the review.

Innovation and futures workstream

8. Officials from the Department of the Prime Minister and Cabinet, Ministry of Business, Innovation, and Employment, and the MoH are continuing to meet with PWC ahead the workshops scheduled for 29 June and 8 July. PwC has sent placeholder invitations to attendees. Your office can be provided with a list of invitees on request.
