Contributing factors to this low uptake include: participation is optional with some employees preferring to continue with nasopharyngeal swabbing. during the prototype there is a continuing requirement for nasopharyngeal testing to be carried out on participating workers. The Ministry is currently working with border agencies to increase uptake and determine how saliva testing can be best aligned to the wide variety of work patterns. 		
d vaccination of border workforce	МВІЕ	•	•	 Staff testing: Compliance reporting is at 98%, up 1% from last week, for staff who worked in the week of 5-11 July 2021 when adjusted for the Hamilton/Waikato cyber-attack issue. If you include Hamilton data our compliance is sitting at 91%. Compliance reporting for Hamilton facilities is averaging 14%. More detail in the report. This week, the MoH report on compliance takes into account some test confirmations from Waikato DHB. The data feed from the Waikato DHB lab to BWTR has been re-instated and results from 11 June 2021 to 12 July 2021 have been sent through. There are about 4,000 earlier results still to be sent. These results were not included in this report, which is why the rate of compliance stated is slightly lower than the figures presented by MoH. Vaccinations: BWTR shows, of the workforce on site, 94% have had two doses of the vaccine, and 3% had one dose, of staff who worked in the week of 5-11 July 2021. Vaccination follow-ups for those with an 'unknown' status in BWTR last week did not identify any instances of unvaccinated people going on site. One incident was identified on the ground. There were no exceptions granted last week. MIQ-issued vaccination certificates continue to be issued periodically as vaccination status data is being updated. This indicator will remain amber while work is underway to resolve the ransomware attack, learn from the saliva testing prototype and improve the limitations of BWTR information. 		
Testing and	Vaccinations Order Amendment came into effect 15 July. Border sector engagement is ongoing by agencies, including face-to-face meetings being held by MoH, Maritime NZ and DHBs with ports around the country. Supporting information for PCBUs made available the 12 July, with translated versions to follow. Vaccination delivery planning is underway with DHBs both individually and collectively. The initial MoH focus is local adaptation to local need through collaboration with DHBs and local employers. The baseline number of active border workers at maritime ports and airports, who are in scope of the amended Order and currently on the BWTR, shows 1462 are unvaccinated (as at 8.00am 14 July data). An author unknown number of additional individual workers are expected to be identified and entered into the BWTR as PCBUs assess both the 'anticipatory nature' and 'affected items' elements of the amended Order age their current workforce. This is the subject of further work in coming weeks. The indicator remains at amber due to implementation issues and risks.

All returnees on managed return flights are required to enter a managed isolation facility for at least 14 days upon arrival into New Zealand.

A number of facilities have already commenced remediation work in advance of submitting their formal remediation proposal. Our independent HVAC engineer has reviewed and provided feedback on eight of the remediation proposals received to date. A further two remediation proposals, along with the HVAC engineer's feedback were reviewed by MIQs Ventilation Remediation Advisory Group (VRAG) last week bringing the total number reviewed to date to eight. Regarding ventilation systems the status remains amber as we assess implications on the MIQ system of delivering the remediation works across the portfolio. Automated invoices have been issued up to 24 June 2021 (please note invoices do not go out until returnees leave a MIF and hence the two week lag), while those invoices we have to manually produce are issued up to 26 May 2021 (excluding exceptions and aircrew). The new invoicing platform has generated over 8,000 invoices, with a value of more than \$34m, in its first six weeks of operation. We have developed a methodology for addressing the pre-25 March 2021 invoice backlog and work continues on building the solution. Debt Recovery: We have sent a total of 100 invoices worth \$332k to a debt collection agency. We will send invoices in batches to the debt collection agency meaning the figure will not change every week. This indicator will remain amber while working through the backlog of invoices.

surveillance and testing Po	•	•	Updated COVID-19 Testing Guidance: The latest update of the Ministry's six-weekly COVID-19 Testing Guidance for the Health Sector took effect from 8 July. The COVID-19 Testing Guidance supports the more broadly focused COVID-19 Testing Plan. The primary focus of the Testing Plan is improving testing at the border to quickly identify and manage infections in those most at risk. The secondary focus is improving testing in the community to quickly identify any community transmission of COVID-19, should it be present. Key messages in the Testing Guidance highlight the importance of winter testing, having tests if symptomatic regardless of vaccination status, and the importance of testing all symptomatic people, including children and the elderly, particularly in light of the growing prevalence of the highly-infectious Delta variant of the virus.

2.1 Insights of Note Written by the Department of the Prime Minister and Cabinet

2.1.1 Flight Arrivals and Departures





Figure 1: International Flight Arrivals and Departures – 19 April to 13 July0

For the period of 19 April to 13 July (following the opening of Quarantine Free Travel with Australia) there were a total 246,859 arrivals into New Zealand, and 250,420 departures. There were 3,561 more departures from New Zealand over this period than arrivals. Total arrivals and departures are illustrated in figure 1 below with a breakdown of these arrivals and departures by port given in figure 2 (arrivals) and figure 3 (departures).

2.2 Insights of Note Written by the Ministry of Health

2.2.1 COVID-19 International Perspectives: 13 July 2021

The number of COVID-19 deaths reported worldwide has surpassed 4 million in the past week. Cumulative cases are now exceeding 180 million and daily reported cases are again increasing after a long period of decline. In an update on 12 July 2021, WHO DG Ghebreyesus said the Delta variant has now been recorded in 104 countries, spreading particularly quickly in countries with low vaccination rates and it is expected to become the dominant COVID-19 strain circulating worldwide. 2

The following summary includes Indonesia, India, United Kingdom (UK) and Fiji as country case-studies. In the past fortnight, the UK and Indonesia were the points of departure from where the highest number of acute cases were imported into New Zealand, followed by India.^{3 4} New Zealand is currently providing additional support to Fiji in the current outbreak. As such, this has also been included as a country case-study.

International Spotlights

Indonesia

- As at 11 July 2021, the seven-day average of daily new cases is 34,371, up from 24,111 one week prior.⁵
- As at 11 July 2021, the seven-day rolling average of daily new deaths is 840 deaths, up from 492 one week prior .6
- The seven-day average test positivity is 26.6 percent and rising quickly, indicating that the number of COVID-19 cases in the country is likely to be significantly underreported.⁷
- Vaccination rates are low, approximately 7.8 percent of the population have received one vaccine and 5.5 percent are fully vaccinated as of 11 July 2021.⁸
- Whole genome sequencing has been limited in Indonesia, but data collected indicates the Delta variant is the dominant strain in circulation.⁹

Indonesia has imposed a lockdown in parts of the country until 20 July 2021, including the main island, Java, and Bali. Furthermore, from 12 July, Singapore and the United Arab Emirates have suspended transit for all travellers from Indonesia, removing the primary route for returning New Zealanders. Transit appears to remain possible through Qatar and Tokyo, but these routes are currently untested and may be prohibitively expensive for many travellers. There have also been revised vaccination requirements for foreign nationals arriving, departing, and travelling domestically in Indonesia.

India

- As at 11 July 2021, the seven-day average of daily new cases is 41,307, continuing a downward trend from 43,700 one week prior. 14
- As at 7 July 2021 the seven-day average test positivity is 2.3 percent, indicating testing exceeds the WHO threshold for comprehensive surveillance of COVID-19.¹⁵
- Approximately 17 percent of the population have received one vaccine. 5.3 percent are fully vaccinated as of 11 July 2021.¹⁶
- The second wave has been attributed mostly to the Delta variant. 17

Cases in India have continued a downward trend since their peak in May 2021 as states follow the five-fold strategy of 'Test-Track-Treat-Follow COVID Rules-Vaccinate'. Although the decline in cases is encouraging, there is concern growing as the level of tourism has increased and local authorities encourage domestic travel in the hope of addressing severe economic issues. 19 The Indian Medical Association has warned that both the government and public have become complacent, engaging in mass gatherings without following COVID-19 protocols. 20

UK

- As at 11 July 2021, the seven-day average of daily new cases has increased to 31,285, up from 24,503 one week prior.²¹
- In the past 30 days, 98 percent of the 4,269 sequenced samples have been the Delta variant.
- Most restrictions are likely to ease in the UK from 19 July 2021.²³
- The rate of the vaccine rollout is slowing in the UK, however 51 percent of the population are fully vaccinated as of 10 July 2021.²⁴




Figure 1: Cases and deaths per million in the United Kingdom from 05 February 2020 to 10 July 2021

Hospitalisations and deaths in the UK remain low despite new cases rising, which is being attributed to high vaccination rates (Figure 1), particularly in older and vulnerable populations.²⁵ The majority of those being admitted to hospital have been unvaccinated.²⁶ Those aged over 85 are still being hospitalised at the highest rate per person, although the relative increase since the beginning of the latest wave is more pronounced in younger people, particularly in those aged 15 to 24.²⁷

Fiji

- As at 11 July 2021, the seven-day average of daily new cases has increased to 622, up from 367 one week prior.²⁸
- There are 245 COVID-19 patients in hospitals in Fiji, with 43 being severe and two critical.²⁹
- Testing rates remain high, the seven-day daily test average is 3,604 as of 11 July 2021.³⁰
- Approximately 60.2 percent of the target population have received one vaccine and 11 percent are fully vaccinated.³¹
- The government aims to fully vaccinate 80 percent of Fiji's target population by 1 November 2021.³²

There have been reports that many Fijians are unable to stay at home and isolate due to a lack of support such as food rations.³³ Furthermore, many Fijians live in poor, crowded conditions, making social distancing and isolation difficult.³⁴

3. Ministry of Health



3.1 Policy/Programme Updates

3.1.1 COVID-19 Vaccine and Immunisation Programme

As at 11.59 pm on 13 July 2021, 1,404,343 vaccinations have been delivered, including 564,789 people who are fully vaccinated. Of those fully vaccinated, nine percent are Māori, six percent are Pasifika, and 16 percent are Asian.

80,363 Māori have received their first dose of the COVID-19 vaccine, which represents ten percent of the total population who have received their first dose as at 13 July 2021.

177 sites were active on 13 July 2021.

The production plan for the next seven days is for 156,597 doses across New Zealand.

Supply

The expected Pfizer delivery of 180,180 doses arrived on 13 July 2021 as planned. s9(2)(b)(ii)

provide sufficient supply for the rollout to Group 4 which commences for those over 60 from 28 July 2021.

Vaccine approval

On 7 July 2021, Medsafe granted provisional approval for the Janssen COVID-19 vaccine to be used in New Zealand for individuals 18 years of age and older. A Cabinet paper that will provide options on the best use of the Janssen vaccine in the New Zealand context is being prepared and will be considered by Cabinet in August 2021.

Incident reporting

This week we have received reporting that highlighted issues when a specific combination of syringe and low dead space needles is used. This issue has the potential to impact on dosage administered and therefore immune response, so has been treated with the highest priority by the Programme.

Updated clinical guidance and advice has been given to providers, and additional supplies of suitable needles have been distributed. An investigation into the root cause of the underlying issues has also already commenced.

Rollout for Groups 3 and 4

A model is being developed to understand the impact of opening up bookings for Group 4 age bands. It will estimate the capacity for each DHB to meet the proposed new volumes for each DHB. This will include an estimate of how many weeks it will take for new bands to be fully booked, given known bookings and production plans. The model is being demonstrated to DHB Senior Responsible Officers this week and a draft of the model will be provided to your office on 21 July 2021 for discussion.

Workplace vaccination

The planning blueprint and expressions of interest form for businesses and providers that would like to be involved in workplace vaccinations are now available on the Ministry of Health website. Detailed planning continues with both Fonterra and Mainfreight as pilots for this approach.

Mass vaccination event

The Northern Region Health Coordination Centre (NRHCC) will begin the targeted invitation process next week for the first mass vaccination event which is scheduled for 30 July-and 1 August 2021.

The Ministry of Health has developed a blueprint for planning and delivering mass vaccination events, modelled on the approach taken by NRHCC. This guidance is intended to support other district health

boards (DHBs) that wish to deliver high-throughput pop-up events. The blueprint will be shared directly with DHBs and published on the Ministry of Health website with other guidance on vaccine delivery.

General practice and pharmacy rollout

There has been increased interest from primary care providers in becoming vaccination sites and we continue to engage with the sector through fortnightly newsletters and webinars.

A playbook for onboarding primary care providers has been developed, with the first version due to be released on 16 July 2021. This will take providers through a step-by-step process to become a vaccination site, setting them up to succeed and ensure clinical quality and patient safety. This will also support national consistency.

Use of the national booking system (Book My Vaccine) is currently optional for primary care providers that have existing booking functionality with their current patient management systems, but use is encouraged, and the playbook outlines how it can be used.

The electronic payments system to support invoicing for, and payments to, providers commissioned on a price per dose basis went live on 1 July 2021. This has been well received by both DHBs and Primary Care. Providers are now being transitioned to this payment mechanism.

Book My Vaccine

All DHBs are now on, and using, the National Immunisation Booking System. Data migrations from existing systems to Book My Vaccine are also now finalised.

As of 13 July 2021, Book My Vaccine holds 493,151 active future bookings at 136 vaccination sites.

Technology

In addition to the work done to ensure all DHBs were onboarded to Book My Vaccine, the past week has also seen a huge range of new technology releases. These include enhancements to the COVID-19 Immunisation Register (CIR), improvements to Post-Event reporting, additional features and functionality within the Inventory/Orders Portal and a suite of changes within the COVID-19 Immunisation Customer Support (CICS) tool.

Equity

More than 40 organisations have been advised on their successful proposals for funding under the \$2 million funding package for iwi/Māori organisations to deliver tailored communications campaigns to whanau. The Ministry of Health is working on contract negotiations worth more than \$1.9 million and more funding may be allocated later.

The Ministry of Health is in the final stages of fully distributing \$16.25 million to Pacific health providers and Pacific DHBs to support Pacific equity in the COVID-19 vaccine roll-out.

The Ministry of Health has set-up dedicated vaccinator events with IMAC for Pacific nurses in Auckland. Four training events are planned with 25 to 30 places for Pacific nurses in each event. This will result in an addition of up to 120 Pacific nurse vaccinators, and the Ministry of Health intends to scale up this process across other regions.

A \$2 million funding package to deliver tailored communications campaigns for disabled peoples has received 41 applications for funding. A panel met on 2 July 2021 to assess the applications and 35 applicants are recommended for approval worth \$1.329 million. Contracts for successful applicants and letters for unsuccessful applicants are being drafted. Any remaining funding will be reprioritised across other vaccination work for disabled people.

Workforce

As of 13 July 2021, 9,171 vaccinators have completed COVID-19 vaccinator training and 3,917 vaccinators have actively vaccinated in the programme so far.

This week the Programme Steering Group also approved the Workforce data integration plan, which will support workforce data analysis, identify current and future gaps in the workforce, and allow time for a planned and considered approach to any solutions proposed and implemented. The new solution will have centralised data on vaccinators including ethnicity and will enable matching of vaccinators from initial training and certification, authorisation, locations of work, administration of vaccines through to when they are no longer an authorised vaccinator.

Distribution and inventory management

As at the end of the day on 13 July 2021, we have made 1,343 deliveries to sites across the country. This equates to delivery of 236,604 vials or 1,419,624 doses.

Rollout of the vaccine to Polynesia

Cook Islands

As of 7 July 2021, a total of 20,100 vaccines have been administered in the Cook Islands and 82 percent of the population is fully vaccinated. The Cook Islands has started vaccinating the remote outer islands, and the vaccination of Palmerston will be supported by the HMNZS Wellington in July 2021 following the delivery of vaccines to Tokelau.

Niue

Vaccine rollout in Niue was completed on 10 July 2021.

Tokelau

Plans are well under way for Tokelau to commence its vaccine rollout from 20 July 2021. The HMNZS Wellington departed New Zealand for Tokelau with the vaccines on 12 July 2021.

Vaccine Ministers' approval for dose donation to Tokelau was received on 9 July 2021.

Other countries

Planning continues with Samoa, Tonga and Fiji while we await Medsafe's regulatory approval of the AstraZeneca vaccine. s6(a)

Next steps

We will provide you with a further update in the next Weekly Report.

3.2 Technical Advisory Group: Update

COVID-19 Vaccine Technical Advisory Group

The COVID-19 Vaccine Technical Advisory Group (CVTAG) met on 6 July 2021 and discussed the following matters:

- advice for vaccination in the frail elderly
- preliminary advice on the decision to use the Janssen vaccine once provisionally approved by Medsafe
- Vaccine Alliance Aotearoa NZ (VAANZ) research trial
- preliminary advice about the risk of myocarditis with the Pfizer vaccine.

The next CVTAG meeting is scheduled for 13 July 2021.

COVID-19 Technical Advisory Group

The COVID-19 Technical Advisory Group (TAG) meeting is scheduled for 23 July 2021.

3.3 Ethnicity Collection in the COVID-19 Vaccine and Immunisation Programme

This item updates you on concerns being raised by the Iwi Chairs Forum on the ethnicity and iwi affiliation data collection approach in the COVID-19 Vaccine and Immunisation Programme. The Forum may approach the media or contact you and Hon Peeni Henare. Members working for the Data Iwi Leaders Group have indicated that they may pull back from using national immunisations booking system (NIBS) if this matter is not resolved. Their anxiety is to know their iwi are vaccinated and safe.

The Ministry of Health recognises the importance of having accurate ethnicity data to help ensure equity in vaccination uptake and is obliged under its Ethnicity Data Protocols to ensure people regularly have the opportunity to supply and confirm their ethnicity.

Iwi affiliation data collection is an additional consideration to ethnicity data collection. They are both important aspects of a person's identity, however, the collection of iwi affiliation is still developing in the health and disability sector. Collecting iwi affiliation alongside the vaccine rollout is the first stage, with future work needed on using the information collected and embedding iwi affiliation data into the 'core' systems.

Ethnicity data collection

We understand that the Iwi Chairs Forum's current concerns are mainly about the collection of ethnicity data through the booking and vaccination process.

In prioritising the rapid scaling up of the COVID-19 Vaccine and Immunisation Programme, a consequence is that there has been limited capacity to immediately address the collection of ethnicity data at vaccination sites.

We have put systems in place for the National Health Index to supply the COVID-19 Immunisation Register with existing ethnicity details. This provides an interim solution but does not address some known data accuracy issues that can be improved by applying Ethnicity Data Protocols at the time of vaccination.

Iwi affiliation data collection project

A separate iwi affiliation data collection project has been set up, initially targeting the COVID-19 Vaccine and Immunisation Programme via the NIBS and vaccination sites.

The affiliation project includes representatives from the Data Iwi Leaders Group and Te Arawa as well as Statistics New Zealand. The project has developed draft Iwi Affiliation Ethnicity Data Protocols and a co-design implementation pathway, including linking from NIBS where Māori descent is confirmed at the time of booking.

The project steering group has agreed Terms of Reference, the project charter, scope and phases. The project is working to deliver this during the vaccine rollout to Group 4 with the aim to bring this online as early as possible.

One of the complexities that the affiliation project is addressing is that the exact method of ethnicity collection will depend on the type of vaccination site. General practices can use the existing systems to update ethnicity, but the Ministry is having to work on support for vaccination sites that do not have existing system capability. Collection will be according to the Ethnicity Data Protocols.

Next steps

The Ministry of Health is working through the implications of enabling ethnicity and iwi affiliation data collection at vaccination sites as soon as possible.

We are maintaining regular contact with Karen Vercoe, the chairperson of the Data Iwi Leaders Group under the Iwi Chairs Forum.

We are continuing work on the iwi affiliation data collection project with the aim of collecting iwi affiliation data during the Group 4 rollout and will keep you informed on progress through the Weekly Report.

4. Managed Isolation and Quarantine Weekly Report



4.1 Top Items to Note

4.1.1 New South Wales Managed Return Flights

The key focus this week has been the response to NSW returnees. An MIQ Incident Management Team has been meeting twice daily to oversee activities. MIQ operational staff and its partner agencies have responded quickly and no significant operational issues have occurred. The response has placed the whole MIQ system under significant pressure.

We are managing the operational changes required as a result of the returnees – for example, the suspension of cohorting is meaning that exercise and smoking times are being carefully managed to maintain the cohorts.

MFAT have issued approximately 600 Urgent and Exceptional applications (UaE). Air NZ have almost met their capacity and a decision is pending on reallocating some UaE rooms from Qantas to Air NZ if Qantas is unable to use their UaE capacity. MIQ continues to monitor the UaE situation closely.

There are currently 63 border averters. Customs and border agencies are looking at how we can reduce the amount of border averters before they board flights in Australia.

We have worked with Police and Security personnel to ensure we are prepared for an expected increase in behavioural issues to deal with at a facility level.

We will continue to brief you and seek your decisions where required. Future briefings will address responses to future demand for urgent and exceptional applications and how to implement decisions around fees.

4.1.2 Staff testing update – compliance statistics for 5 to 11 July 2021

To avoid duplication, please see MOH's BEB dashboard for the latest compliance figures for the MBIE total 'active' workers.

We are reporting on a subset of that full data separately here, which focuses on the compliance of workers on site for the previous work-week. This way we ensure we have data for a full 7 day cycle, drawn from the Who's-on-Location system.

While we look at the total 'active' workforce measure as part of our follow up work, we also want to understand the compliance of our workers on site in the last week.

Of the 128 that still need an NHI-match, 102 were created in BWTR in the last 7 days. The Workforce Testing team is investigating the remaining 26 workers.

27 workers (excluding Hamilton workers) were recorded as '11+ days overdue' in the report for the week 28 June to 4 July 2021. We have confirmed ten of them have been swabbed, two are incorrect sign-ins; one has been referred to MOH as they are no longer employed; and we are still awaiting a confirmation from employers of test compliance for the other 14.

20 workers (excluding Hamilton workers) were recorded as '11+days overdue' in the report for the week 21 to 27 June 2021. We have confirmed 15 have since been tested, one is a possible NHI-issue that we are working with MoH to rectify, two have received their second follow ups (if they remain non-compliant they may be escalated to MoH) and two have received their first follow up and will continue to be monitored.

4.1.3 Vaccination of frontline staff update

For workers on site for the week 5 July to 11 July, BWTR shows 94% had two doses of the vaccine, 3% had one dose and the remaining 3% (145 workers) had vaccine status 'unknown'.

Of the 145 with an 'unknown' status, 128 still require an NHI match. The Workforce Testing team is investigating the remaining 17 workers to confirm vaccination status.

One incident was identified on 10 July 2021. A truck driver booked to pick up sporting equipment from a facility entered through the gate and signed in. On exiting their vehicle they were questioned about their vaccination status by security staff. The driver then indicated they were not vaccinated. They got back into the truck and left the facility six minutes later.

Of the 87 with a vaccination status 'unknown' mentioned in the 28 June to 4 July 2021 Weekly report:

- 34 have had their vaccination data updated within BWTR.
 - Of the 34, 17 have had their second dose and 17 have had their first dose.
 - All 17 who have only had their first dose are within the 35 days compliance timeframe.
- Of the 53 who still have an 'unknown' status in BWTR:
 - Seven are fully vaccinated.
 - One has had their first dose within 35 days.
 - Seven are compliant but have been referred to MOH due to possible NHI-matching issues.
 - Three were incorrect sign-ins to Who's-on-Location.
 - One received a vaccine exemption to fix lifts.
 - For the remaining 34, the Workforce testing advisors are still awaiting confirmation of vaccination status and continue to follow up with employers.

4.2 Operational Update

4.2.1 Capacity update

As at 7am 14 July 2021, there is currently no availability on MIAS.

Existing rooms are continuously being re-released through cancellation and clean-up processes, and can be up to hundreds of rooms per day. Returnees who are the most persistent, or online at the right time in MIAS, are then able to secure a room on a date that works for them.

We are expecting to release rooms for December 2021 with an initial release of 40%, together with a top-up for August to 100%, September to 90% and October to 60%, towards the end of July 2021.

4.2.2 Ombudsman update

We responded to the following from the OPCAT office this week:

- Two final reports for the Commodore and SO hotels;
- Provided log in credentials to the OPCAT inspectors to Learn@MIQ so that they can experience the same learning as our workers;
- Received two inspection notifications and related information requests Sudima Christchurch (inspection 13 July 2021), and Crowne Plaza (inspection 14 July 2021).

Feedback on the Thematic Report that the Ombudsman intends to publish is due 16 July 2021. Further information about this report and its recommendations will be provided in the weekly report.

4.2.3 Security Enhancement Programme update

MBIE remains on track to move to a blended security workforce by August 2021. We are aiming for an indicative blend consisting of 55% NZDF, 9% Avsec and 21% MBIE security officers whilst retaining a residual contracted security workforce of around 15% from a single provider.

The MBIE security officer workforce transition is progressing:

- Wellington (target 16): 16 MBIE Security Officers on rostered shifts.
- Hamilton (target 15): 15 MBIE Security Officers onboarded, inducted and now on rostered shifts.
- Rotorua (target 18): 16 MBIE Security Officers onboarded, inducted and now on rostered shifts.
- Auckland (target 105):
 - 7 x MBIE Security Officers onboarded/inducted (week beginning 5 July 2021) and now on rostered shifts.
 - 19 x MBIE Officers onboarded/inducted (week beginning 12 July 2021) and will be rostered on shifts from next week.
 - 23 x MBIE Security Officers due to be onboarded, inducted the week beginning 19 July 2021.
 - Remaining officers being onboarded weekly for an additional three to four weeks dependant on role/offers being accepted.

Wellington and Christchurch no longer has any hotel contracted security personnel.

Remaining hotel contracted security personnel will be progressively offboarded.

The deadline for applications for Time Sensitive Travel allocation for people arriving in September and October 2021 is 14 July 2021. As at midday Tuesday 13 July 2021, 24 applications requesting allocations for 52 people have been received.

There was a systems error on 14 July 2021 which meant individuals from the USA and UK were unable to submit applications for TST as they were unable to enter their travel dates. This issue has been resolved. As the application window has closed, we are proactively contacting those who were impacted by this error to offer them the opportunity to complete their application.

The average number of complaints received each week since the start of MIQ is 105. For the last four weeks the average is 200 per week.

This week we have received 339 new cases and have resolved 349 cases.

The large increase in complaints this week was driven by 248 complaints about MIAS (228 about being unable to book and 15 about technical queries or issues). Complaints about Emergency allocation also remained high with 36 received (15 complaints about a declined decision and 16 cases where we have provided information about the process). Numbers for fee waivers remained steady however isolation exemptions cases doubled, mainly due to border averters seeking early departure.

5. Border Executive Board Report



5.1 Key Issues Being Considered

5.1.1 QFT Travel

QFT arrangements continue to be a focus of effort within the border sector. Over the past week, the border sector has worked on:

- Three different types of flights from Australia (QFT, managed green return and 'red' flights from Svdney)
- Following Cabinet's decision on 12 July, MFAT will start initial discussions with Samoa, Tonga and then Vanuatu regarding one-way quarantine free travel from these countries to NZ by air.
- Two-way QFT with Niue
- Maritime QFT with Australia

5.1.2 Mandatory Vaccination for Border Workers – Phase 2

The COVID-19 Public Health Response (Vaccinations) Amendment Order 2021 came into effect on 15 July 2021.

Border sector engagement is ongoing by agencies, including face-to-face meetings being held by MOH, Maritime NZ and DHBs with ports around the country. Supporting information for PCBUs was made available on 12 July 2021, with translated versions to follow.

Vaccination delivery planning is underway with DHBs both individually and collectively. The initial Ministry of Health focus is local adaptation to local need through collaboration with DHBs and local employers.

The baseline number of active border workers at maritime ports and airports, who are in scope of the amended Order and currently on the BWTR, shows 1462 are unvaccinated (as at 8.00am 14 July data). An as-yet unknown number of additional individual workers are expected to be identified and entered into the BWTR as PCBUs assess both the 'anticipatory nature' and 'affected items' elements of the amended Order against their current workforce. This is the subject of further work in coming weeks.

5.1.3 Smart and safe border: Reconnecting New Zealanders

The Chair of the Border Executive Board and Chief Executive of Auckland International Airport Ltd jointly chaired a meeting on 13 July 2021 to commission the public and private sector working together to ensure the border is prepared for future changes. Attending were the Chief Executives from Wellington and Christchurch airports; Air New Zealand; the Board of Airline Representatives New Zealand; Sir Brian Roche and Rob Fyfe. The Border Executive Board agencies were all represented.

Attendees supported using an Agile Sprint process – this will look at how airports, airlines and border agencies, including the Ministry of Health, could be ready to put a variety of (yet to be confirmed but to include PDT, Vaccination Certificates, and Rapid Arrival Testing) measures in place to support international travel and trade. The intent is to be able to provide you with future options. A separate note will be provided with more detail.

Air New Zealand attended the Border Executive Board meeting on 8 July 2021. s9(2)(a) from the airline's Digital Innovation & Strategy team presented on Air New Zealand's trial of the IATA travel pass. In its current format, this does not entirely meet the needs of New Zealand government agencies, however it could potentially be leveraged by New Zealand's Travel Health Pass.

The lead for the Travel Health Pass work is transitioning from Ministry of Transport to the New Zealand Customs Service. Mat Black from Customs has been appointed as the Travel Health Pass Programme Director.

5.1.4 Systems Improvement: Integrated targeting and border operations

At its meeting on 8 July 2021, the Border Executive Board considered the proposal to improve integrated targeting and border operations. It was noted that the project's proposed initial focus was on: taking steps to enhance the resilience and relevance of the Integrated Targeting and Operations Centre (ITOC) by updating its

governance structure; extending the ITOC targeting service to better support 24/7 operations; bringing in the Ministry of Health and AVSEC interests; and managing risks across multiple modes (such as cargo and marine sectors).

Feedback and engagement had been received from nine different agencies (Customs, Immigration, MPI, NZ Police, AVSEC, Health, Maritime NZ, NZ Security Intelligence Service, and DPMC). These agencies were all keen to collaborate and extend the benefits of integration to achieve operational effectiveness as well as strategic alignment.

6. New Zealand Customs Service Weekly Report



6.1 Items to Note/Updates

6.1.1 Maritime

FV Viking Bay - A total of 15 infected crew were removed from the Spanish registered fishing vessel FV Viking Bay currently berthed at Queens Wharf Wellington to the Quarantine facility based at the Grand Mercure hotel. Five crew who did not test positive remained on board.

The Spanish owners of the vessel were contacted to obtain permission to reduce the number of crew required on board from seven to five. On 13 July 2021, one further crew member was taken off the vessel and delivered to MIQ.

The vessel has a slow leak which had been kept under control by the crew. Now with only reduced crew remaining on board, the ship's agent is making arrangements for the leak to be investigated and repaired if possible.

Customs remains onsite at Queens Wharf to ensure the safe isolation of the four remaining crew, and these crew will be tested regularly to ensure they do not develop COVID-19.

FV Playa Zahara - The FV Playa Zahara is another Spanish registered fishing vessel with 18 crew on board. Their last crew exchange through New Plymouth was 20 June, with all crew (seven) transferring on board testing negative for COVID-19.

During its time at sea, the master of the vessel has stated that 15 out of his 18 crew have displayed mild to medium symptoms, but stated he would only return to port once he obtained health clearance. The master has now asked to come to port for a crew exchange without health clearance, and the Ministry of Health has issued a quarantine notice over the vessel to facilitate the crew exchange.

The vessel berthed in New Plymouth on 13 July 2021 for testing purposes. All crew were tested one by one.

Following the completion of the tests, the vessel departed the port and remained coastal until results were received. Testing results received on 14 July 2021 show that 17 of the 18 crew have tested positive for COVID-19. The Spanish owners have agreed to send the vessel to Lyttelton.

All crew are feeling well. The estimated time of arrival at Lyttelton is 16 July 2021 at 9.00 pm at normal speed. But if the vessel is to undergo remote pilotage, this needs to be done in daylight so their estimated time of arrival would then be 17 July 2021 at 8.00am.

6.1.2 Pre-Departure Testing

For the period 5 July 2021 to 11 July 2021, there was one infringement issued:

7 July 2021 – A passenger arriving from China via the Singapore was issued an infringement after failing to produce evidence of a PDT documentation. The passenger claimed the documentation was on their phone but they had erased all data from the phone when leaving China.

7. COVID-19 Chief Executives Board

7.1 Items to Note/Updates

The COVID-19 Chief Executives' Board did not meet this week. The meeting scheduled for 20 July has been cancelled, and the next fortnightly meeting for the Board will take place on 3 August.

8. COVID-19 Independent Continuous Review, Improvement and Advice Group

8.1 Items to Note/Updates

The COVID-19 Independent Continuous Review, Improvement and Advice Group met on 13 July for their regular fortnightly meeting. Graham MacLean, Head of System Readiness and Planning attended the meeting to discuss the Q3 Response Plan and to give an overview of readiness planning events underway. Sir Brian Roche, Rob Fyfe and Philip Hill attended the Border Executive Board's Safe and Smart Border — Reconnecting New Zealanders hui on 13 July. A programme of work has been proposed for completion by the end of September and the Group will remain actively involved.

Sir Brian Roche and Philip Hill visited the SCL laboratory at Wellington Hospital on 14 July to gain a better understanding of the procedures and technology the lab use for the processing of COVID-19 tests (nasopharyngeal and saliva). The Group also met with Stephen McKernan from the Health and Disability Transition Unit on 15 July to gain an insight into the direction of the health reform process.

9. Strategic COVID-19 Public Health Advisory Group

9.1 Items to Note/Updates

The Strategic COVID-19 Public Health Advisory Group met on 14 July to discuss the content of their next report to the Minister. The Group discussed recommendations for relaxing the border restrictions based on New Zealand's COVID-19 vaccination programme. The next meeting for the Group will be on 28 July.

10. Business Leaders Forum

10.1 Items to Note/Updates

The Business Leaders' Forum is considering actions that they could take to support businesses to encourage the use of contract tracing as part of the planned health behaviours campaign. The date for the next meeting is yet to be confirmed.

Government Modelling Group

11.1 Items to Note/Updates

The Modelling Steering Group are continuing to work with Te Punaha Matatini researchers on their next paper. This explores the relationship between using different tools for travellers (testing, tracing, isolation requirements) and the expected frequency and severity of outbreaks as vaccination rates increase. This work is due to be completed over the next couple of months, but we are working towards interim deliverables for the end of July which can inform the Reconnecting New Zealanders August Cabinet discussion.

Next week, officials will be engaging with Professor Tony Blakeley (University of Melbourne) and team, who have recently published modelling (situated in the Australian context) which explores similar themes. We will take a view on the comparability between their modelling and the work of TPM and ESR, domestically. Key points will be provided in next week's weekly report.

Officials will meet with Rodney Jones (Wigram Capital) next week to discuss current reflections on the international context.
