Purpose

1. This Aide-Memoire provides an update on the status of system readiness to go live with the next steps of Reconnecting New Zealanders.

Background

- This report provides an update on readiness for: (1) Visitor visa classes for Pacific Island
 Forum countries from 16 May; (2) Step 4 Accredited Employer work visas and Work Visas
 from 04 July; and (3) Step 5 Visitor / Education Visas from 31 July. Appendix A provides
 an overview summarising the Reconnecting New Zealanders (RNZ) steps, settings, and
 pathways.
- Appendix B includes a readiness report dated 11 May 2022.

Traveller volumes and airline updates

Passenger numbers since step 1 of Reconnecting and comparisons:

- 4. The latest Reconnecting step, unvaccinated resident class visa holders eligible to enter New Zealand from 11.59pm on 05 May, has been completed successfully.
- Numbers of travellers since RNZ Step 1 (28 February to 10 May):
 - i. Total 248,338
 - ii. Australia 156,004
 - iii. Rest of the World 92.334
- 6. We have seen a small increase in travellers in the past week, with the average daily total travellers at 5,489 up from the previous week's average of 5,450.
 - i. Australia average of 1,527 per week for seven days from 28 February and 3,108 for the seven days from 13 April and 3,263 for the past seven days.
 - ii. Rest of the world average of 202 per week for the seven days from 28 February and 688 for the seven days from 13 April and 1,113 for the past seven days.


Key operational updates including readiness

- 7. This report has an overall **Green rating**, with activities remaining on track for the current steps included in the report.
- 8. Work is ongoing, between agencies, to confirm the remaining outstanding aspect of what happens when a visitor gets COVID-19. This relates to what services are available to travellers who do not have a place to safely isolate and how the system can provide Alternative Accommodation Support for travellers that find themselves in this situation. This does not prevent any of the Reconnecting steps from occurring.
- 9. As the system continues to evolve, the following updates are included here for awareness:
 - a) Unvaccinated resident class visa holders are now eligible to enter New Zealand. Some operational challenges have been encountered, however overall, the border operations teams are managing this latest change. Whilst updates to the New Zealand Traveller Declaration (NZTD), scheduled for release on 12 May, will see the automation of the issuing of the conditional travel pass, travellers will continue to be required to have their residency status verified manually at both check-in and upon arrival in New Zealand.
 - b) Overall arrival testing compliance remains steady at 78%¹ while overall positivity at 1.6%. From next week the three single Rapid Antigen Test (RAT) packs provided to arriving travellers will be replaced with a single box containing four RAT tests. Work is ongoing with MPI airport staff (who distribute the Welcome Packs, including RAT test kits) to prepare for this adjustment. Whilst the flyer in the Welcome Pack remains current, Q&As and websites will be updating to reflect the change during the coming week.
 - c) Ministry of Health are preparing a report, for the Minister for COVID-19 Response, to progress a change cycle for future Air Border Order (ABO) and Director-General Notices. This cycle will review public health and administrative requirements and collate a range of adjustments to remove inconsistencies, better align across agencies, and provide simplicity to the process.
 - d) The Ministry of Health has agreed to provide weekly reporting to the Associate Minister for COVID-19 regarding the numbers of travellers presenting for testing, community testing, whole genome sequencing (WHS), and increasing ESR capacity for WGS. This report will start Friday 20 May.

¹ Currently the total number of testing on arrival travellers are under-reported as there are a number of travellers who have not correctly completed the New Zealand Traveller Declaration (NZTD) and are therefore not added into the National Border System (NBS) which is the system utilised to record this data.

Appendix A: RNZ summary

Reconnecting New Zealanders: Policy Summary

Entry pathways

Travellers will enter using one of four entry pathways - only three of these are in use today:



Quarantine Free Travel – entry without quarantine or isolation for eligible travellers from some Pacific Countries



Testing on arrival – entry without quarantine or isolation for eligible travellers with testing before departure and after arrival (on day 0/1 and 5/6)
This is the main entry pathway to New Zealand.



Managed solation and Quarantine-full MIQ for other travellers – small number of exceptional travellers are allowed to use MIQ (e.g. refugees, Antarctic survey team, Air Crew). These individuals can leave MIQ at any time.



The **self-isolation pathway** is not currently in use.
