Official Information Act request relating to the status of COVID-19 response legislation

Thank you for your Official Information Act 1982 (the Act) request received on 14 September 2022. You requested:

- 1. Which legislation/statute/Act created for and during the COVID response is still active and enforceable
- 2. When that legislation lapses (if it has an expiry) or if it is enduring

Response to your request

In relation to your second question, the below statutes have provided the legislative basis for our response to COVID-19. The powers in the Health Act 1956 supported our initial response to COVID-19, with a shift to using the powers in the Epidemic Preparedness Act 2006 and COVID-19 Public Health Response Act 2020 to support our ongoing management of the virus:

- Health Act 1956 section 70 enables medical officers of health to exercise powers to manage the immediate risk of infectious diseases. There are no current section 70 notices in force.
- **Epidemic Preparedness Act 2006** enables the Prime Minister to create an Epidemic Notice where an outbreak of a quarantinable disease is likely to significantly disrupt essential government and business activity. The Epidemic Notice triggers powers in other legislation to support an epidemic response.
 - The Epidemic Preparedness Act does not expire, however the Epidemic Notice itself needs to be reviewed and renewed every three months for it to stay in force.
 The current Epidemic Notice will expire on 20 October if it is not renewed earlier.

These expire either when the Epidemic Notice expires or is revoked, or as set out in the individual orders (see Attachment 1).

 COVID-19 Public Health Response Act 2020 – is bespoke legislation which was specifically enacted to support the public health response to COVID-19.

The Act gives powers to the Director-General of Health and the Minister for COVID-19 Response to support the ongoing management of COVID-19 using COVID-19 Orders.

- The Act is due to self-repeal in May 2023. Any COVID-19 Orders that are still current when the Act self-repeals will also self-repeal at that time. A list of Orders currently in force can be found on https://covid19.govt.nz/about-our-covid-19-response/legislation-and-key-documents/

Immediate Modification Order title	Revocation
Epidemic Preparedness (Customs and Excise Act 2018—Appeals) Immediate Modification Order 2020	This does not have a revocation clause
Epidemic Preparedness (Employment Relations Act 2000—Collective Bargaining) Immediate Modification Order Revocation Order 2022	This order will be revoked on 1 July 2023.
Epidemic Preparedness (Local Government Act 2002) Immediate Modification Order 2020	This order is revoked when the <u>Epidemic Preparedness</u> (COVID-19) Notice 2020 expires or is revoked.
Epidemic Preparedness (Oaths and Declarations Act 1957) Immediate Modification Order 2020	This order is revoked when the <u>Epidemic Preparedness</u> (COVID-19) Notice 2020 expires or is revoked.
Epidemic Preparedness (Protection of Personal and Property Rights Act 1988—Enduring Powers of Attorney) Immediate Modification Order 2020	This order is revoked when the <u>Epidemic Preparedness</u> (COVID-19) Notice 2020 expires or is revoked.
Epidemic Preparedness (Sale and Supply of Alcohol Act 2012—Licence Application Inquiries) Immediate Modification Order 2020	This order is revoked 30 working days after the Epidemic Preparedness (COVID-19) Notice 2020 expires or is revoked.
Epidemic Preparedness (Social Security Act 2018—Temporary Additional Support) Immediate Modification Order 2020	This does not have a revocation clause
Epidemic Preparedness (Wills Act 2007— Signing and Witnessing of Wills) Immediate Modification Order 2020	This order is revoked when the <u>Epidemic Preparedness</u> (COVID-19) Notice 2020 expires or is revoked.
