# CANTERBURY EARTHQUAKE (LOCAL GOVERNMENT ACT 2002) ORDER (NO 2) 2011

- 1. On 17 October 2011 the Canterbury Earthquake Recovery Review Panel (the Review Panel) considered the Canterbury Earthquake (Local Government Act 2002) Order (No) 2 (version PCO 15515/3.0).
- 2. The Review Panel considered the letter from Marilyn Little of the Department of Internal Affairs dated 13 October 2011.
- 3. The Review Panel noted that the Order in Council will permit the four councils in greater Christchurch to defer the preparation of their long-term plans by one year and makes consequential modifications to the operation of the LGA for any council that chooses to defer.
- 4. The Review Panel is of the view that the draft Order is necessary, expedient and meets the purposes of the Canterbury Earthquake Recovery Act 2011.

#### **Recommendation**

1. The Review Panel recommends to the Minister of Local Government and the Minister of Canterbury Earthquake (Local Government Act 2002) Order (No) 2 (version PCO 15515/3.0) be made without change.
