REPORT AND RECOMMENDATION OF THE REVIEW PANEL

CANTERBURY EARTHQUAKE (EDUCATION LEGISLATION) ORDER 2012

- 1. On 6 March 2012 the Canterbury Earthquake Recovery Review Panel (the Review Panel) considered the Canterbury Earthquake (Education Legislation) Order (version PCO 15718/5.0).
- 2. The Review Panel considered the letter from Frances Kelly from the Ministry of Education dated 28 February 2012.
- 3. The Review Panel noted that the draft Order in Council will extend the effect of a number of provisions in the Canterbury Earthquake (Education Act) Order 2011 for another year, and proposes three new provisions that will help ensure a smoother recovery and renewal process.
- 4. The Review Panel is of the view that the draft Order is necessary, expedient and meets the purposes of the Canterbury Earthquake Recovery Act 2011.

Recommendation

1. The Review Panel recommends to the Minister of Education that the Canterbury Earthquake (Education Legislation) Order2012 (version PCO 15718/5.0) be made without change.
