### REPORT AND RECOMMENDATION OF THE REVIEW PANEL

#### CANTERBURY EARTHQUAKE (RESERVES LEGISLATION) ORDER (NO 2) 2011

- 1. On 28 September 2011 the Canterbury Earthquake Recovery Review Panel (the Review Panel) considered the Canterbury Earthquake (Reserves Legislation) Order (No 2) 2011 (version PCO 15455/6.0).
- 2. The Review Panel considered the joint letter from Ann Clark of the Department of Building and Housing and Doris Johnston of the Department of Conservation dated 27 September 2011.
- 3. The Review Panel noted that the Order in Council will repeal and replace the Canterbury Earthquake (Reserves Legislation) Order 2011, to extend the timeframe for powers provided to councils to permit reserves to be used for earthquake response and recovery efforts.

- 4. The Review Panel noted that numbers of matters were raised during the consultation round. All were considered by the Panel. The Panel concluded that all matters raised were adequately covered by the draft order.
- 5. The Review Panel is of the view that the draft Order is necessary, expedient and meets the purposes of the Canterbury Earthquake Recovery Act 2011.

#### **Recommendation**

1. The Review Panel recommends to the Minister of Conservation and the Minister of Housing that the Canterbury Earthquake (Reserves Legislation) Order (No 2) 2011 (version PCO 15455/6.0) be made without change.
