Discussion:

- 1. The Community Forum received a summary from Mr Sewell on the city, its progress to date and Ngai Tahu.
- 2. The presenter described the history and inception of Ngai Tahu Property and explained that since its inception Ngai Tahu Property has grown in both commercial value and in physical presence in the city and Canterbury.
- 3. The presenter discussed lessons from the way Christchurch has grown in the past and how they can be used to plan for recovery and development now and up to 50 years in the future. He spoke about the city's identity and what it means to have a vision for the city and strong leadership and strategy to see that through, especially in central Christchurch. He emphasised the growth of suburbs around shopping centres and the pull this has created away from the city's core.
- 4. The Forum heard that transport matters (particularly the road layout in the central business district), residential solutions, the residential red zone and investment capital are of a particular concern to the presenter.
- 5. The Forum noted that and agreed with the key theme of the presentation is that Christchurch needs to develop a strong vision, with strong leadership and strategy. The Associate

Minister Wagner assured the Forum and the presenter that the new structures created, such as Regenerate Christchurch, will achieve this.

- 6. The Forum also discussed Christchurch's agricultural/land surroundings and how the city fits in with the wider region too. They noted that the dairy industry is still very important in our wider area, and has helped populate outlying small towns.
- 7. The Forum and the presenter discussed the consultation undertaken throughout the rebuild so far.
- 8. The Forum was interested in the presenter overseas information gathering, particularly in California where new technologies were being used to combat liquefaction ands they discussed this with the presenter.
