## **Public Notice: Draft Land Use Recovery Plan**

The Minister for Canterbury Earthquake Recovery Gerry Brownlee has received the draft Land Use Recovery Plan from Environment Canterbury. Environment Canterbury developed the draft Land Use Recovery Plan with its strategic partners Christchurch City Council, Selwyn and Waimakariri District Councils, Te Rūnunga o Ngāi Tahu, NZ Transport Agency and CERA, as directed in November 2012 under Section 16 of the Canterbury Earthquake Recovery Act 2011.

The Draft Land Use Recovery Plan looks at the impacts of the earthquakes on residential and business land use, and provides a pathway for the transition from rebuild to longer term planning. The draft LURP sets a framework and provides delivery mechanisms necessary to:

- Rebuild existing communities
- Develop new communities
- Meet the land use needs of businesses
- Rebuild and develop the infrastructure needed to support these activities
- Take account of natural hazards and environmental constraints that may affect rebuilding and recovery

The draft Land Use Recovery Plan has been publicly notified in The Press and written comments on the Plan are being accepted. The closing date for written comments is 5pm on Friday 2 August 2013

The Canterbury Regional Council (ECan) has delivered the Draft Land Use Recovery Plan to the Minister for Canterbury Earthquake Recovery.

The Draft Land Use Recovery Plan sets a framework and provides delivery mechanisms that, as a result of the Canterbury earthquakes, are necessary to:

- Rebuild existing communities
- Develop new communities

- Meet the land use needs of businesses
- Rebuild and develop the infrastructure needed to support these activities
- Take account of natural hazards and environmental constraints that may affect rebuilding and recovery

The Minister for Canterbury Earthquake Recovery invites members of the public to make written comments on the Draft Land Use Recovery Plan, in accordance with Section 20(3)(b) of the Canterbury Earthquake Recovery Act 2011. Written comments received before 5pm on Friday 2 August 2013 will be considered by the Minister when deciding whether to change, withdraw or approve a Land Use Recovery Plan.
