1	<p>Welcome and Chair's update</p> <p>The Chair welcomed attendees to the meeting and provided some key developments since the last meeting:</p> <ul style="list-style-type: none"> The National Security Group within the Department of the Prime Minister and Cabinet (DPMC) was undergoing some structural changes. An paper on the RCOI Response Outcomes Framework (the Framework) was expected to be considered by the Cabinet Social Wellbeing Committee in August. <p>The minutes of the prior meeting (2 March 2023) were taken as read and accepted for publishing.</p>
2	<p>Recommendation 18: Comprehensive review of counter-terrorism legislation</p> <p>The Ministry of Justice provided an update on the review of the counter-terrorism legislation in response to recommendation 18 of the RCOI report. The next phase of the review included examining the wide counter-terrorism legislation landscape. Cross agency workshops would be held in August and September 2023 to progress this.</p>
3	<p>Response progress reporting</p> <p>DPMC provided an update on the RCOI response progress reporting, comprising two pieces of work:</p> <ul style="list-style-type: none"> Assessing the implementation status of the recommendations at the thematic level Highlighting the key achievements to date across the response <p>This work would provide decision makers with better data on the response so far and identify remaining gaps and risks.</p> <p>New Action (number 34): DPMC to circulate PPT of the response progress reporting to agencies.</p>
4	<p>Future Royal Commission of Inquiry Priorities</p> <p>Due to time constraints, updates would be provided to DPMC after the meeting.</p>

5	<p>Any other business</p> <p>DPMC informed the group that the RSG risk register would be refreshed.</p> <p>The Kāpuia secretariate noted there would be two more Kāpuia hui scheduled for 2023 in August and December. At the August hui, the roopu would consider what they thought the priorities for the incoming Government could be. Kāpuia Secretariat hanked agencies for their assistance on the proactive release of 'Kāpuia Feedback to Agencies' which would be published on the Kāpuia webpage on 31 July.</p>
