Official Information Act request: Resignation of Andrew Bayly

Thank you for your Official Information Act (the Act) request received on 24 February 2025. You requested:

Under the OIA may I please request all communications, briefings, advice, emails, texts, evidence of meetings, regarding Andrew Bayly and complaints about his behaviour or conduct

On 25 February you clarified your request was broader than the events connected to Hon Bayly's resignation and covered any information concerning conduct matters during his time as a Minister. I have not included information regarding Hon Bayly that is not related to conduct matters.

Your request was also partially transferred to the Prime Minister for information he holds in relation to your request. The Prime Minister's Office will respond to you in due course. Please find the response from the Department of the Prime Minister and Cabinet below.

Information being released

I have decided to release the relevant parts of the documents listed in the table below, subject to information being withheld as noted. Where information has been withheld in full, it has not been provided. The relevant grounds under which information has been withheld are:

- 1. section 9(2)(a), to protect the privacy of individuals
- 2. section 9(2)(ba)(i), to protect the supply of similar information in the future
- 3. section 9(2)(f)(iv), to maintain the confidentiality of advice tendered by or to Ministers and officials
- 4. section 9(2)(g)(i), to maintain the effective conduct of public affairs through the free and frank expression of opinion
